THE CITY OF CHRISMAN WAS CALLED INTO EXECUTIVE SESSION BY MOTION ON TUESDAY, JUNE 20TH 2023 AT 7:12 P.M. FOR PERSONEL. WITH THE FOLLOWING MEMBERS PRESENT: MAYOR MOORE, COMMISSIONER THAD CRISPIN, COMMISSIONER CORY CHANEY, AND CITY CLERK LELA RAMEY.

EXECUTIVE SESSION DISCUSSION:

Mayor Moore – Do we have money for summer help? Crispin – Yep. Mayor Moore - I have got some applications here. This kid here has worked here before I guess. Chaney – Who is it? Mayor Moore – Andrew Newman. Ramey – He isn't really a kid but he is younger than you. Crispin – Is he the one that was a teacher or teacher's aid? Ramey – He was an aid at Grade School, but he has back problems. Crispin – Help okay. Mayor Moore – He was wanting a mowing job. But we could see if he is interested in anything else. Somebody said he was a good worker, and that he had worked here before. Ugh another one is Addison Phipps she didn't turn in an application but she did text me to let me know she would be interested. Do you know her? Chaney – Yes Mayor Moore – Who's daughter is she? Chaney – Cory and Sam. Yep. Their youngest. Mayor Moore – Okay, Victoria Labaume, Grace Strange, this other guy Newman left his other jobs due to back issues. Crispin – Due to what? Mayor Moore – Back issues. Ramey – I am pretty sure it is because he has had back surgery. Chaney – I think so too. Mayor Moore – Here is a Mitchell Gober, he wants to work on the street department. Crispin – Is he wanting something part time or full time. Mayor Moore – It doesn't say...summer 2023 I think I can't read his writing. I don't know him do you Lela? Ramey – No I don't. Chaney – I think he went to Chrisman, Yeah he went to school with my daughter. Did he work out at Dollar General for a while? Mayor Moore – I think so. Chaney – At Wal-mart and NAL, yeah that is who that is. I don't know what you have in your budget but. Crispin – That's what I was looking at if we hire at \$13/hour then 10 weeks would be 5,200 bucks. I could swing that. Mayor Moore – So do we want one in sewer and one in street and ally? Crispin – Sewer is not my call. And I don't know what their budget is. However, I do have enough for one in street and I can't go over that. It would be a 40 hour week but if it raining or what not then they don't have to be here. Mayor Moore – I have been trying to get these guys to do and I can't ever find them. It is like a game of hide and seek. Crispin – Oh I know, your guess is as good as mine. I don't know if Landon Alexander's is still in here but I know Ryan talked to me so that is another one if he doesn't already have a job. Ramey – Those are the ones I had so Kaylen may have more in her drawer. Crispin – We can put it on the Agenda for next meeting. Mayor Moore – Would it be okay if I interviewed them. Crispin – Yeah Chaney – Yeah, I think I would be cautious of that because of this. And then this one here I have heard somethings about so I think I would be cautious about that too. He may not pass his test. Victoria I'm not sure I know this one. Crispin – That is Ashley Mobley daughter. Mayor Moore – Is she a good kid? Chaney – I think she is. Crispin – As far as I know. Mayor Moore – I was also going to talk about Tracy Luster. He is just out of his mind. He came up here and we (Tom & I) talked to him for 2 hours. And we are still on the war path, but I do think he made up with Steve. Luster is trying to get this Tracy Davidson out of his house. She wants to go to rehab but she is still getting her stuff from him I think. Then we had another call on the two story blue house behind NAPA. I guess they had a party and didn't clean up. I guess Kaylen took the call and told Tom and Tom said that is not my job. He said that was Cody's job. It's his job and it's easy to go down there and tell them they need to clean it up. Chaney – Yeah he is here to enforce that. Mayor Moore – And I think another issue is with these abandon vehicles German's is willing to take them and they will put them in their lots and we don't have any expense it would be on the registered owner of the vehicle. Tom told Ray that you done really good on these sticker and things here. (holding a red door tag) I guess Ray had put 20 up or so and Tom came in and said to Ray that he was doing so good that he could just do the rest of them. I don't want that I want him to work on it too. Ray is just part time. Crispin – I agree he is the chief. Mayor Moore – Yes he is the chief and that is just the way it has got to be. There are people that are cleaning up. I have saw people doing somethings in order to clean up. Some of them are going to see what we will do. Crispin – I agree they are going to wait to see what you will do. Chaney – Oh Yeah For Sure. Mayor Moore – Have you notice the vehicles that are backed up to their garages? So you know what is going on there. Chaney – He needs to fallow through. Mayor Moore – He is great on his administrative stuff. And he did good today with the whole Luster. Everything you tell him he wants to

turn it around and put it on someone else or say you can't do that it is against the law. Chaney – He has corned me two or three time lately and said the same thing. About ordinances and things. If you open that can of worms with these trailers and things then this other issue will happen. If you go back and look the ordinances it says that you can only have 2 vehicles per house hold and so many pet in a house. So it's like deflect over here and lets talk about this stuff over here. Crispin – Well it has also been brought to my attention that we need to be careful on golf carts and side by sides because I have had a couple of people feel like they have been harassed on a side by side when numeracy golf carts don't have all the sticker, turn signals all of it. That is just because a couple have been followed home and then stopped when the side by side rider has seen even golf carts that night on their way home that don't have everything they are supposed to. Mayor Moore – So side by sides have to have their stickers too. And see that was the other thing that just came about I knew you did it before and you do it again on Saturday and people aren't able too. Chaney – That night when he was resisting to that. Mayor Moore – And the deal with the donuts have been delayed. So are we good with Bob? Bob took a tour of the plant he is satisfied that he can do it. Michael there were some concerns. I feel like we could try him and if it doesn't work out then... Crispin – I know that we would just have to bring it to a vote. That's all I can say. Mayor Moore – I don't want to loose you either. Crispin – We can just bring it to a vote and see what happens I have already brought my concerns to you. I just don't know how everybody else feels. I just know how I feel. Mayor Moore – I don't blame you myself. Crispin – He called me on the phone wanting to know the in's and out's and said that he was just going to wing it and doesn't really know anything. He started asking questions on budget and things like that so. Mayor Moore – This is Michael? Crispin – Yeah. We can bring it to a vote. I mean if we have a vote on that... Chaney – That is my understanding. When I came on Dan presented me to the council and then someone made the motion and someone seconded that motion. And then went to a vote. I believe that is the way it is supposed to work. Crispin – I thought so too. Chaney – I will say that whoever take the positions of the water, sewer, street. They will have to stay on top of these guys. Mayor Moore – Most likely. Chaney – Just like Michael sitting out there watching Gore pump out that tank. There was no reason why he needed to do that. Gore actually called me and said hey we are going to be leaving in ten minutes this is our last one. Just so that Michael would leave. And then he called me back like an hour and a half later and said we got 15 more loads out of this thing. I said I thought you were going to stop. He said that was just to get Michael to leave because he stood here all day and watched me. Gore said we have told him he doesn't need to do that time and time again. He just wont listen. Crispin – I have to tell Cody numerous times that he will do a job and do it half effort and I will have to send him back to do it again. Just like trimming a tree around a stop sign. He trimmed it for cars to see but not for trucks you just still see that tree. He did the bare minimum so I have to tell him again. That will be something else that will be everyday. Mayor Moore – And who else are you going to get? Chaney & Crispin – Agreed Mayor Moore – It's just sad\, so sad. Chaney – I guess I don't understand they have been told time and time again and they just don't get it and I don't know what to do. Mayor Moore – And they know you can't spend the whole day with them. It's impossible. Ramey – Can you.....Sorry I am sorry I'm probably over stepping the line. Go Ahead. Chaney – are they still making the log of what they do every week? Crispin – I don't get anything... so I doubt it. I know at one time they were writing it down on the calendar. Chaney – Okay Mayor Moore – We need a report every two weeks. From each one of them. Crispin – When I worked at Georgetown we would have to fill out a weekly log. And I know that we have talked about doing that way back when. And sometimes they write it on the calendar sometimes not. I get a lot of complains of laziness. Chaney – And that is one of my concerns about putting one of these kids with one of them. Not only lazy but safety. I know I don't want one of these kids getting hurt. But at the same time I know that we need help. I think it will be a matter of who you put with them and there has to be some kind of directions given to all three of them or however many we are able to hire. Mayor Moore – So I will just interview them and go from there. So what do we do if it is a no go on him and they come back asking why? Crispin - Do we give them our explanation. Like I said we can bring it to a vote and see what happens. I don't know how you guys are voting. And that will just be how it is. Mayor Moore – Now this other guy has his water license. He is a license plumber I think. Chaney – I know who he is. He is a retired pipe fitter. He used to live in Georgetown for years. Crispin – So he is the one that bought (unintelligible) house? Chaney – I don't know. Mayor Moore

– Is he next door to Jordan's? Crispin – He is on the far house I believe. In between Jordan's and the Beal's. Or no actually I think Beal's is between him and Jordan. I think. Mayor Moore – What was his late name? Chaney – Bill Hall yeah he is a retired pipe fitter. Mayor Moore – Well what did he say when he stood up? He was interested in being a commissioner? Chaney – Maybe he was going to see how it goes. And he had a water license at one time? Mayor Moore – I think he still does. Chaney – Okay Mayor Moore – Michael and I met with um is it Brian from... Ramey – Ryan Mayor Moore – Ryan he said we were going to have to put sticker out or a notice on every bodies door. About being under violation of the arsenic and stuff in the water. Crispin – We are still under violation for arsenic? Mayor Moore – Yeah I guess it has been for some months. Crispin – Where is it coming from? Mayor Moore – Is that how you got it too? Ramey – Um I don't know.....I got an email that it was supposed to be attached to the bills but nothing about it being attached to the doors. Mayor Moore – We have to go door to door and do that... Crispin – Which they used to have to go door to door. I just didn't know that we were in violation. How in the heck are we in violation? Chaney – I don't know. Crispin – Where is it coming from. Chaney – It has to be coming from the pipes somewhere. Crispin – Someones service line or one of our main lines. Ramey – Cody Lewis house keeps failing and I think we should take it off the list. Chaney – For lead and copper or arsenic? Ramey – Lead and Copper. So I don't know if there is arsenic there with it or what the chemical combination is. Crispin – Yeah I don't know. We can discuss that. Mayor Moore – And then the rest of the meeting is mayor reports and stuff like that. Okay I'm done.
