We will not have to pay any of the taxes because it will become a municipal property. Mayor – how much money do we have in the gambling fund? Ford - \$4849.00. Haddix – I called IML about grants and we can go online to grantfinders.com. I would like to search for grants for dilapidated buildings and tearing down buildings.

Had several complaints about vehicles speeding in town. Also, golf carts and ATV's have children standing on the seat.

Mayor – find out what it will cost for closing to assume the property at 221 S Illinois.
